In the 1 issues of Volume 3 published during the year 2019, a total of 4 article were published (at an average of 1 article per issue) of which, articles were published from authors all around the world. A total of 24 research scientists from all over the world reviewed the 4 article published in volume 3. Average publication lag time of an article was further reduced to 2-3 weeks.

During the calendar year 2020, a total of 6 Reviewers joined the board of Environmental Risk Assessment and Remediation and contributed their invaluable services towards contribution as well as publication of articles.
